**The Town Council reiterates its comments of November 2010 and remains of the opinion that this application should be refused. The lack of amenity space and dedicated parking in this cramped corner of Malthouse Square are severe drawbacks to a change of use from office to household accommodation. Having thrice been refused permission by Wycombe District Council, confirmed on the second occasion by the Planning Inspectorate, using the only existing space available, it seems inevitable that the only alternative is to build upwards. This may well solve the floorspace constraints but does little to improve the ambiance of living in this tiny cramped corner site for which the developers had to devise a use in the 1980's. The building does not, and will not, enhance the Conservation Area in any regard.**
